**SPECIFIC AGREEMENT FOR STUDENTS EXCHANGE BETWEEN  
NATIONAL UNIVERSITY OF CUYO, ARGENTINE REPUBLIC  
AND  
UNIVERSITA' IUAV DI VENEZIA, ITALY**

--The **National University of Cuyo (UNCuyo)** from now on), located at University Center, New Building of Rectorate, M5502JMA - City of Mendoza, Province of Mendoza, Argentine Republic, represented by its Rector **Esther Lucía SÁNCHEZ** and the **Università Iuav di Venezia (IUAV)** from now on), located at S. Croce 191-Tolentini, 30135 Venice, Italy, represented by its Rector Prof. **Benno ALBRECHT** agree to celebrate this Specific Agreement for Students Exchange according the following terms and conditions:---

**1. Purpose**

The purpose of this Specific Agreement is to establish an exchange program for undergraduate and graduate students so as to grow academically and culturally.-----

**2. Institutional Coordination**

The UNCuyo appoints Secretariat for Research, International Relations and Postgraduate Courses as the responsible to coordinate the Students Exchange Program; and the IUAV designates the Office of International Relations, which shall have the following tasks:-----

- 2.1 To work as link between both Institutions.-----
- 2.2 To select the candidates who shall participate in Students Exchange Program.-----
- 2.3 To facilitate information concerning the academic and administrative aspects related to the exchange, such as information regarding to the city, migratory process and accommodation in order for the exchange student to develop as a profitable experience, both academically and culturally.-----

**3. Students quota and Selection Process**

3.1 The Exchange shall consist of **one (1) undergraduate student** per academic semester, per Institution. Both parties shall review the program constantly to rectify any imbalance that may arise, and shall make the necessary adjustment in order to maintain the expected reciprocity.-----

3.2 Each Institution shall establish the formalities for the participation and selection of exchange students, based on their academic performance and other subjects that may be taken under consideration from both parties.-----

**4. Characteristics of the Exchange Program**

- 4.1 The exchange students may take courses that are frequently offered at the counterpart Institution.-----
- 4.2 At the end of each semester, the host Institution shall provide a Transcript validating the academic performance of the exchange students.-----

- 4.3 Exchange students from the UNCuyo shall count with an English B2 level and an Italian A2 level according to the Common European Framework of Reference at the moment of the application. On the other hand, the exchange students from IUAV shall have a Spanish B2 level according to the Common European Framework of Reference at the moment of applying.
- 4.4 The exchange students shall pay the correspondent fee at their home Institution, if applies.-----
- 4.5 The host Institution shall not charge any fee to the exchange students.-----
- 4.6 Exchange students are responsible for all the expenses related to transportation, health insurance and others related to stay. -----
- 4.7 Exchange students are subject to rules and regulations of the host Institution, and they must comply with them. -----
- 4.8 Exchange students shall hire a health insurance of the non-refundable kind and fulfill the migratory regulations of the host country.-----
- 4.9 The exchange students shall have access to the services and infrastructure of the hosting Institution.-----
5. **Termination, Renewal and Revocation**
- 5.1 This Specific Agreement shall be effective from the last signature herein, and shall remain as long as the Framework Agreement is, and it may be renewed upon one of the parties' request.-----
- 5.2 This Specific Agreement might be resigned before its expiration upon the request of one of the institutions, without penalties, and shall be communicated to the other within the period no less than NINETY (90) days. -----
- 5.3 In the event this Specific Agreement expires, this situation shall not damage the students who had started their studies at the host institution and they shall be able to complete them without any inconvenient-----
6. **Resolution of Disputes Clause**
- In the case of differences or disputes in the interpretation or application hereof, THE PARTIES first agree to arrive to a direct and friendly solution. If the conflict still persists, THE PARTIES, in mutual agreement, shall designate one or more mediators, depending on the complexity of the subject, and the mediator shall have recognized trajectory and technical solvency at an international level regarding the dispute being handled. In such case, the pertinent regulations to moderate the arbitral procedure shall be established by mutual agreement. -----
