MEMORANDUM OF UNDERSTANDING BETWEEN Università IUAV di Venezia AND

Urbego-International Federation for Housing and Planning, Denmark

Whereas

- Università Iuav di Venezia, whose activities are institutionally limited to teaching, training and research in the academic areas of architecture, town and territorial planning, restoration, the arts, theatre and design, has a network of relations with numerous specialised national and international bodies and with which it has cooperative relations in the fields of research, teaching, training together with other activities related to the institute's primary functions;
- Urbego-IFHP is a multidisciplinary platform of young planning professionals from all around the globe. Urbego wants to provide rapid responses for specific challenges in cities by applying an in situ approach collaborating with local partners, ranging from civil society representatives to research institutions and decision makers. Urbego has a flexible and solution-oriented approach. Based on the theme of each project, it assembles a different team of young experts selected among Urbego's members to meet the challenges of the case study. It is facilitated by IFHP, International federation for housing and planning.

Urbego's members have a wide range of expertise, going from urban governance, planning, economics, architecture and culture to communication and engagement. Through workshops, these skills are combined with local knowledge from citizens, students and decision makers to find the best solution for the individual case.

Whereas

Università IUAV di Venezia and Urbego IFHP have expressed their wish to set up cooperative relations in the areas of activity of common interest;

it is agreed as follows


Article 1 - Principle of Reciprocity

The Università Iuav di Venezia, hereinafter termed IUAV and Urbego IFHP intend to cooperate in fields and areas of activity of common interest on the basis of the principle of reciprocity.

Article 2 - Activities

The cooperation will, in particular, concern the following activities:

- 1. the implementation of exchange programmes for both teachers and students in the framework of European programmes and other possible arrangements or agreements;
- 2. cooperation in the performance of research and design on matters of common interest as between the structures of IUAV and those of Urbego-IFHP $\,$
- 3. planning and performance of teaching activities in a coordinated manner, including the possible institution of activities that entail reciprocity in the academic qualifications awarded;
- 4. promotion of seminars, meetings, exhibitions and fairs;
- 5. the exchange of documentation, publishing activities.



Article 3 - Convention

The activities of common interest referred to under article 2, appropriately detailed in terms of their content and duration, form the subject matter of a separate convention in which specific mention must be made to the present Memorandum of Understanding.

The convention, whose academic content has been prepared by coordinators designated by each of the institutions, shall be submitted, for approval, to the governing bodies of the institutions signatory to the present Memorandum.

Article 4 - Validity

The present agreement shall have a validity of 3 years commencing from the most recent date of its execution.

On condition that no amendments to the current text are needed, the Understanding may be renewed by a written request authorised by the legal representatives of the respective institutions. The renewal request must reach the other party no later than two months before the expiry date.

The date indicated on the "endorsement for acceptance" shall represent the new commencement date of the Memorandum.

In the event that at the expiry date of the Memorandum the conventions as indicated under article 3, or agreements for the participation in specific research programmes remain in force, the latter shall continue to remain valid until their natural expiry.

The present Memorandum replaces any other previously stipulated Memorandum or framework agreement.
