The provisions recorded below establish the principles and conditions by which University of IUAV, Venice (IUAV) and Pakistan Institute of Fashion and Design (PIFD) agree to cooperate in academic exchange, program development and holding of workshops. Such a cooperative agreement will be realized as established in the following clauses:

I. Legal Framework of the IUAV and PIFD

Both the Director of University of IUAV, Venice and the Vice Chancellor of Pakistan Institute of Fashion and Design may, in accordance with their respective laws and rules, initiate agreements to enhance cooperation, good will and understanding to further contribute to the achievement of their goals and objectives.

II. IUAV and PIFD Common Interests and Objectives

As established institutions in the field of Fashion, both the IUAV and PIFD share interests and objectives in academic exchange for enhancement of their capacity and for promotion of studies in fashion.

Purpose of the Agreement

The IUAV and PIFD jointly agree to subscribe to co-operate in:

- A. Capacity Building of PIFD faculty through admissions in Master and Ph.D programs in Fashion Design at IUAV
- B. Faculty and students exchange for Workshops, Trainings & Seminars and for Academic Programs
- C. Joint Master and Ph.D programs through Distance Learning Model in Fashion Design
- D. Knowledge sharing.
- E. Any other activity of mutual interest.

**LETTER OF INTENT
Between IUAV and PIFD**



A group of five to six faculty members from PIFD and IUAV could visit each institution at mutual convenience. Consequently, workshops may be arranged in IUAV, Venice and PIFD, Lahore for students of both institutes on dates mutually agreed by IUAV and PIFD.

III. Execution of the Agreement

The Specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements.

The sub-agreement will be negotiated and signed by the IUAV and PIFD. Such specific sub-agreements, once signed by both parties, will be attached as annexes to this agreement.

IV. Specific Sub Agreements

The specific agreements between both institutions will specify their objectives, conditions and ways of execution, financial obligations, term of validity, and administrative responsibility within each institution.

V. Term and Termination

This agreement will be effective on the date it has been signed by both parties, and it will be in effect for a period of 5 years. The agreement can be renewed for an additional 5-year period by mutual consent of the parties to the agreement. Both parties reserve the right to terminate this agreement upon written notice given three months prior to the termination date becoming effective. Any changes under this clause will be subject to the terms of any specific sub-agreement.
