
Call for applications for the award of 30 tuition fee waivers for international students enrolling in bachelor and master degree programme at Università Iuav di Venezia, academic year 2024-25, "Study@Iuav" programme ¹

general information

1. Università Iuav di Venezia, in the mainframe of "Study@Iuav" programme, 30 tuition fee waivers for high-achieving international students enrolling in Bachelor and Master degree programmes in the academic year 2024/25. In particular:

> **10** tuition fee waivers for the **MA in Architecture**

> **10** tuition fee waivers for the **MSc in Urban Planning for Transition**

> **10** tuition fee waivers for **other programmes taught in Italian** (laurea e laurea magistrale).

2. "Study@Iuav" tuition fee waivers will be assigned, according to candidates' ranking (see art.3), for a single academic year.

4. Each tuition fee waiver is initially assigned for a single academic year but will be renewed for the following academic year if the student has achieved:

- at least 30 ECTS by 10 August 2025;

- at least 80 ECTS by 10 August 2026;

- At least 135 ECTS by 10 August 2027 (only for students enrolled in Bachelor's degree Programmes)

The tuition fee waivers can be renewed until the first year beyond the normal duration of the Degree Course ("primo anno fuori corso").

The eventual recipients of the exemption will nonetheless be asked to pay the sum of around € 204,00 to cover the regional tax for Academic enrolment and the duty stamp (this amount is pertained to the enrolments of the 2024-25 academic year but is annually revised and can therefore be subject to variations).

5. "Study@Iuav" tuition fee waivers are compatible with every kind of scholarships, eventhose awarded by the Veneto region.

applications

International students, admitted during the first call for application to the English taught programmes are automatically candidates to the "Study@Iuav" programme, International students applying to Italian taught programmes must apply by August 31st 2024, 12pm (CET), through this google form:

Candidates must fill in the form with their personal data, study background details.

selection of beneficiaries

1. Beneficiaries of "Study@Iuav" actions will be selected by 2 commissions nominated by the Rector (one for the ma in architecture and the ms in urban planning for transition, and one for the ba and ma taught in Italian).

These commissions will prepare three different candidates' rankings:

- > by April, 30th 2024, for the master degree programme in architecture;
- > by April, 30th 2024, for the master degree programme in urban planning for transition;
- > by September, 23rd 2024, for the bachelor and master degree programmes taught in Italian.

2. The ranking related to Italian taught programmes will be prepared considering these criteria:

- up to 70 pt for the CV and background of studies;
- up to 20 pt for candidates with status of refugee or as person who otherwise need international protection or as national of one of the developing countries identified as such by the Italian government (decree no. 1455 of 09/06/2017 issued by the Italian Ministry of Education, Universities and Research);
- up to 10 pt in case of an Italian language certification.

3. The ranking related to the master degree programme in architecture and the master degree programme in urban planning for transition will be prepared having regards to the admission ranking. A preference will be accorded to candidates with status of refugee or as person who otherwise need international protection or as national of one of the developing countries identified as such by the Italian government.

article 4 – acceptance of the award

1. Beneficiaries must carry out the pre-enrollment procedures at the Italian Diplomatic/Consular Authority in the country where the degree has been awarded for the visa issue.

2. The beneficiary must communicate her/his renouncement of the fee waiver via e-mail by writing to study@iuav.it. The fee waiver will then be assigned to the next suitable candidate in the ranking.

processing of personal data

All personal data provided by applicants shall be processed in compliance with the principles and provisions of the Italian and European Data Protection regulations and exclusively for the purposes of this call for applications. Data will be processed using electronic and manual (paper) methods. The provision of the requested data is compulsory, under penalty of the candidate's application not being considered.
