The scholarship is co-funded by the National Agency for New Technologies, Energy and Sustainable Economic Development (ENEA)
	The theme of this proposed scientific research is based on a knowledge of the theories and dynamics linked to the projects and processes of the circular economy, urban metabolism and Nexus relationship of resources linking it to the theoretical-methodological system of planning and design applied in urban and territorial action (policies, plans, programs, projects, actions). This research will be characterized by the attention paid to the governance processes, evaluation and management of resources of the urban environment. Innovative production and consumption models that promote the urban circular economy will also be examined. Moreover, the theme can be deeper explored in relation to:     The theory and practice of planning, implementation and evaluation of public policies and plans, at different scales and in relation to circularity in the management of change processes;     Citizens participation in the construction of policies and in the co-creation of new circular consumption models;     Land use practices, the production of common goods and their regulations;     The relationship between urban and rural in the management of natural resources and ecosystem services.     The transversality required by these fields of action compared to traditional disciplinary fields is supported from an interdisciplinary research practices.
