## CALL FOR APPLICATIONS

**4 scholarships and 4 tuition fee waivers “Venice Water Lab Scholarships” a.a. 2025-26<sup>i</sup>**

### The rector

Given that

-By Rectoral Decree No. 296/2025, prot. 39826 dated 13/05/2025, the Call for the establishment and awarding of 10 scholarships and 10 tuition fee waivers under the project “Venice Water Lab Scholarships”, academic year 2025–26, was published.

-Following this procedure, by Managerial Decision No. 186/2025, prot. 59297 dated 26/06/2025, 6 scholarships and 6 tuition fee waivers were awarded.

-As a result, 4 scholarships and 4 tuition waivers remain available.

-The selection process will be reopened for the awarding of the remaining scholarships and waivers, maintaining the same eligibility criteria and evaluation methods set out in the original call.

### ART. 1 – AIM, AMOUNT AND DURATION

1. For the academic year 2025–26, **Iuav University of Venice is reopening the selection procedure** for the awarding of the remaining **4 scholarships and 4 tuition fee waivers** under the “*Venice Water Lab Scholarships*” project. The project includes the establishment and awarding of scholarships worth **€5,000.00** each (gross of any applicable deductions), along with **tuition fee waivers** for students who decide to enroll/who are already enrolled in the following English-taught programmes: **Renewable Energy Engineering in Coastal Environment** and **Sustainable Transportation and Smart Maritime Mobility**.

2. The scholarships and fee waivers will be awarded to eligible candidates in the ranking list referred to in Article 4, and will be valid only for the academic year of enrolment at the University. Any renewals will be considered exclusively for students holding international protection status (refugee status, subsidiary or special protection, or humanitarian protection), and based on academic merit.

3. The Venice Water Lab Scholarships are incompatible with other scholarships, including those awarded by the Veneto Region.

### ART. 2 – SUBMISSIONS OF APPLICATIONS: TERMS AND PROCEDURES

1. Applicants to the Master's degree programs in Renewable Energy Engineering in Coastal Environment *and* Sustainable Transportation and Smart Maritime Mobility who are interested in the Venice Water Lab Scholarship Programme must submit their application by **September 3rd, 2025, at 12:00 p.m. (CET)** through the dedicated Google Form available at the following URL: **<https://forms.gle/1QxcWay1Y7gbdq3T8>**

### ART. 3 – SELECTION CRITERIA

1. The selection of candidates will be carried out by a committee appointed by the Rector. The committee will prepare a ranking list for the Master's degree programs in Renewable Energy Engineering in Coastal Environment and Sustainable Transportation and Smart Maritime Mobility, and award the 4 scholarships and related tuition fee waivers based on the admission rankings of the respective programs.

2. The committees responsible for awarding the benefits to candidates in the international programs will assign the scholarships based on a merit ranking, listed in descending order, corresponding to the admission ranking of the respective degree programs.

### ART. 4 – RANKING LIST AND ACCEPTANCE OF THE SCHOLARSHIP

1. Following the selection process described in Articles 2 and 3, **the ranking list will be published by September 15th**. To confirm the scholarship, candidates must reply to the University's communication within 7 days of the notification date. Failure to respond by the given deadline will result in the loss of the scholarship and its benefits.
2. The Venice Water Lab scholarships will be **awarded only after the completion of the enrolment process** and, for international students, the issuance of a student visa. Candidates are responsible for initiating pre-enrolment procedures required for visa issuance at the Italian diplomatic-consular representations.
3. In the event of explicit or implicit withdrawals, the ranking list will be scrolled through until all available scholarships have been assigned.
4. The scholarships will be paid in two instalments: the first by November 30, 2025, and the second by February 28, 2026. Beneficiary students must open a European bank account, preferably by activating the *Carta Iuav*.

#### **ART.5 - PROCESSING OF PERSONAL DATA**

1. The University will use applicants' personal data only for the purposes of this application process, in line with privacy laws (Legislative Decree No. 196/2003 and EU Regulation 2016/679). Data will be handled fairly, lawfully, and only as needed. Full details are available on the University's privacy webpage: <https://www.iuav.it/it/privacy>
