

EXTRACT FROM THE CALL FOR APPLICATIONS A.A. 2026/2027

ARTICLE 5 – PUBLICATION OF RANKING LISTS AND ENROLMENT

1. The results of the selection process will be published on the university's website, both within the personal area and in the public section (Concorsi), from the date indicated in the information sheet.
2. Candidates are admitted to courses in accordance with their position on the ranking list.
3. In the event of a successful placement on more than one ranking list, candidates who have applied for simultaneous enrolment on multiple study programmes will receive written notification from the university of either approval or rejection, in accordance with ministerial regulations.
4. Candidates placed on the ranking list in a position qualifying for admission must complete pre-enrolment no later than the deadline indicated in the individual course descriptions, by visiting the university's website: <https://iuav.esse3.cineca.it/Start.do> and completing the online form. Candidates who do not complete pre-enrolment by the specified date will forfeit their right to enrol.
5. To complete their enrolment, applicants must send an email to the Alta Formazione Office at master@iuav.it, attaching:
 - **a copy of the enrolment application generated automatically** at the end of the online procedure. The document must be signed and completed by hand in the sections relating to the degree (the last section on page 1) and payment methods (page 2);
 - **the receipt for the payment of the first instalment of the enrolment fee**, which corresponds to 50% of the amount indicated in the course description, unless otherwise specified in the descriptions of individual master's programmes and courses;
 - **a copy of a valid identity document**.
6. In addition to the provisions of Article 2, clause 5, candidates holding a foreign qualification must provide their tax identification number, obtained by submitting the relevant form – available at <https://www.agenziaentrate.gov.it/portale/> – to any office of the Italian Revenue Agency, including through an authorised representative, or to an Italian consular or diplomatic office in their country of residence.
7. Candidates admitted conditionally are required to pay, in a single instalment, a non-refundable advance payment of €1,500.00 towards the enrolment fee, in accordance with the instructions to be provided in writing by the Alta Formazione Office, by the enrolment deadline set for each master's programme or course.
Please note that candidates admitted conditionally must send, by 5 March 2027 at the latest, a copy of their degree application, submitted to the university at which they are obtaining their degree, to the Alta Formazione Office at master@iuav.it.
Once the degree has been awarded, candidates must then proceed with enrolment as set out in paragraph 5 of this article, having first given notice in writing to master@iuav.it, and pay, in a single instalment, the difference in the total course enrolment fee indicated in the attached information sheet, in accordance with the instructions to be provided in writing by the Alta Formazione Office.
8. Candidates who are successfully placed on the ranking lists but who do not enrol by the enrolment deadline set for each master's programme or course (as indicated in the programme description) will forfeit their right to enrol, and the places thus vacated will be allocated to other candidates in descending order of ranking.
9. Once enrolment has been finalised by the Alta Formazione Office, which will confirm this in writing to the candidates concerned, each enrolled student may click on the "Certificates" link on the left-hand side of their personal portal page and print out their certificate of enrolment for the master's programme or specialised course.
