CALLS FOR STUDENT EXCHANGE MOBILITY FOR STUDIES

IN EU or NON-EU UNIVERSITIES in the NOTHHERN HEMISPHERE ACADEMIC YEAR 2022/2023

(deadline: March 8th, 2022 at 12:00 a.m.)

For resolving any dispute and for all legal purposes only the Italian version is valid.

The indications described here are mainly valid for the Erasmus+ and International Credit Mobility ICM call for applications but are also valid for the selection of students for mobility in non-EU universities based in the northern hemisphere

Università luav di Venezia, hereinafter referred to as luav, announces a selection for the assignment of places in Erasmus + and ICM International Credit Mobility and in the partner universities in Switzerland, United Kingdom and in non-EU universities based in the northern hemisphere for luav students who intend to carry out learning activities in the academic year 2022/23

The actual partner universities indicated in the calls may be extended/reduced following the renewal and/or amendment and/or conclusion of agreements with IUav

As a consequence the number of grants and their actual allocation are established

- on the basis of the agreements that regulate mobility to and from the foreign Universities
- by the National Erasmus + Agency with which luav signs a specific agreement every year
- the evolution of the epidemiological situation in the world, so that future Government restrictions on mobility between Countries cannot be ruled out at the moment.

Therefore, the availability of exchange places may be subject to change and, therefore, these calls are provisional and not binding, as there may be changes imposed by the governments of Countries and / or the National Erasmus + Agency and / or partner universities..

It should be considered that winning a mobility place for a foreign location does not guarantee acceptance by the foreign university. In case, luav may propose to its student not accepted an alternative location among those available.

GENERAL INFORMATION

Mobility for Studies programme enables students to spend a period of continuous study at another university that has entered into an agreement with IUAV.

Mobility students receive a grant and can attend courses and use structures at the host institute without additional enrolment fees (except for any fees that even local students are usually also required to pay). Students are also guaranteed full recognition of the assessed learning activities carried out abroad, on the condition that they were approved in advance by luav tutor and hosting university. Especially the Erasmus+

Programme and International Credit Mobility make it possible for students to experience a different culture abroad, learn about new higher education systems and meet young people from other countries. Students thus participate actively in the process of European integration and cooperation with Partner Countries. By doing so, Erasmus+ strengthens reciprocal knowledge and academic and cultural dialogue, thus contributing to sustainable development via the exchange of knowledge, while also promoting European values and culture around the world.

Mobility to UK

Despite UK is not entitled to participate at the Erasmus + programme 2021-2027, luav wants to continue, whenever possible, to cooperate with UK universities.

Students interested could, therefore, apply for UK universities, but must be aware of the following:

Acceptance by the UK university is not, at the moment, guaranteed

- Even if UK universities accept selected students, they will have to observe the entrance regulations to UK and, consequently, get informed by themselves about VISA and health insurance;

VISA and health insurance fees, along with other costs related to the entrance to UK or to the acceptance by the UK university will not be covered by luav;

- In most of the cases, starting from January 1st 2021 UK universities ask for ad hoc language certificates in order to release invitation letters for VISA purposes, based on the exchange duration. We suggest students to check accurately the relevant webpages of the UK universities and, eventually, to contact them directly to get more information.

Mobility to Switzerland

Switzerland currently does not participate in the Erasmus+ Programme.


More specifically, there is no EU funding for mobility from and to Switzerland. In order to guarantee the present level of mobility and cooperation, the Swiss Federal Council has devised the Swiss European Mobility Programme (SEMP) as a transitional solution. Thanks to the specific agreements in place, Swiss universities are able to finance the mobility of all incoming students. Grants to students will be provided by the accepting Swiss universities; winners of such exchange places must apply individually to the accepting Swiss location to receive the grant

Mobility to non-EU universities based in the northern hemisphere

Students interested could, therefore, apply for non EU universities, but must be aware of the following:

Acceptance by the non EU universities is not, at the moment, guaranteed

- Even if universities will accept selected students, they will have to observe the entrance regulations to those Countries and, consequently, get informed by themselves about VISA and health insurance;
- VISA and health insurance fees, along with other costs related to the entrance to those countries or to the acceptance by the those universities will not be covered by luav;



- In most of the cases, universities ask for ad hoc language certificates in order to release invitation letters for VISA purposes, based on the exchange duration. We suggest students to check accurately the relevant webpages of the universities and, eventually, to contact them directly to get more information.

General eligibility requirements

Calls are open to luav students enrolled in the academic year 2021-22 according to the current Three-year degree programme (bachelor) or Two-year degree programme (master).

Third year students graduating in the extraordinary session of the 2020/2021 academic year (February/March/April 2022) cannot apply now as they are not enrolled for the 2021-22 academic year. If they are enrolled in an IUAV Master's degree course in autumn 2022, they can contact the International Mobility Service and apply for the places that are vacant at the time of contact and start their mobility in the second semester of 2022/23 if accepted by the host university.

Third-year students enrolled for the academic year 2021-22 who are successful in a mobility placement at the time of their departure (the year in which the mobility is used) must be enrolled for the academic year 2022-23 as out of course or in a Master's degree course at luav;

Third-year students who will graduate in the year 2021/22, in the summer or autumn session up to 31 October 2022, must apply only for destinations for which a mobility place is foreseen in the second teaching period of the academic year 2022/23.

In order to benefit from the mobility placements, students must be regularly enrolled for the academic year in which the mobility scheme is used, i.e. academic year 2022/23.

During the academic year 2021/22 students may not submit more than one application for different study mobility calls at the same time.

Students who also intend to take advantage of Erasmus Plus mobility for internship purposes may apply for the present call provided that the mobility periods do not overlap each other

Students who are not awarded an exchange place in this selection, but are eligible or excluded, may apply for other mobility selections in the academic year 2021-2022.

The application procedures for these students will be detailed in the relevant selection notices. In the event that the student is allocated a place in this selection but is not accepted by the foreign institution, he/she may apply to other student selection notices for mobility in a.y. 22-23.

For these students too, the application procedures will be detailed in the relevant calls for applications. Alternatively, students may apply for an exchange at a foreign establishment that is still available in this selection or in other calls for applications for mobility in the academic year 2022-23.

Students who have already received an Erasmus Plus and/or LLP-Erasmus mobility grant for study and/or internship purposes from the academic year 2007/2008 up to and including the academic year 2021/22 may apply for the Erasmus Plus call for applications.

These students may apply for a further mobility period for study purposes, the maximum duration of which must not exceed the difference between the 12 months foreseen for each study cycle by the Erasmus Plus

Programme, and the number of grant months already used with the Erasmus mobility previously carried out during the same study cycle. If the 12 months provided for are exceeded, the amount of the grant corresponding to the excess period will be requested to be refunded. The choice of location for this selection must be different from those to which you have already travelled.

The NON Erasmus + selection is open to luav students enrolled in the academic year 2021-22 enrolled in the third year of the three-year degree programme (bachelor) or Two-year degree programme (master).

Language requirements

With this call for applications, luav requires a compulsory assessment of language skills. Applicants must contact Istituto Zambler in order to do the assessment of language skills

Each candidate will be awarded a mark for passing the language test as indicated below:

Language test for the language of the chosen venue specified in the list of venues.

- sufficient marks, 20 points
- good marks, 25 points.
- excellent mark, 30 points

Language test for a language other than the language specified for your chosen venue on the list of venues.

- sufficient marks, 5 points
- good marks, 10 points
- excellent mark, 15 points

inadequate marks, 0 points

if not taken -5 (minus five) points

The language requirements specified above must be met in order for luav selection to be eligible. However, luav requirements may be lower than those of Partner Universities. Students are therefore required to check the language requirements of the university where they intend to spend their period; For example: many foreign universities require a TOEFL certificate and many British Universities require a IELTS certificate, which selected students must present when submitting their application forms. Students who are awarded a place at one of these Universities are required to obtain by themselves the necessary certification no later than the deadline established by their host university.

Submitting an application

Each candidate may submit applications for only one vacancy. Applications must be submitted online only through Spin https://iuav.esse3.cineca.it/Start.do,

START DATE FOR THE SUBMISSION OF APPLICATIONS: 15th February 2022

CLOSING DATE: 8th March 2022 at 12 am

List of available exchange vacancies

The list of destinations and their descriptions, hereafter called "vacancies", are published online and are an integral part of the call for applications. These vacancies specify the destination, name of the exchange tutor, exchange field of study, language requirements specific to the destination (if any), Students may apply for one vacancy. Vacancies can be subject to change while the call for applications is open, if significant changes are communicated by the hosting partner university. It is conditional to admission at the hosting university. If the nominated exchange student's application is rejected by the hosting university, the student may be reallocated to another destination. It is the student's responsibility to verify the specific requirements (language and academic requirements, enrolment procedures) and application submission deadlines by checking the official university web page or by contacting the host university and sending all necessary documents in time to the host university

Rankings

- 1 Each candidate will be awarded a score for academic merit:
- for students in the first year of the Three-year BA programme, based on the weighted average of the examination marks obtained by the deadline of 8th March 2022
- for students in the second and third year of the Three-year BA programme, based on the weighted average of the exam marks obtained by 10th August 21;
- for students in the first year of the Two-year MA programme, referring to the grade for the three-year degree;
- for students in the second year of the Master of Science programme, with reference to the weighted average of examination marks obtained by 10th August 21.

It is compulsory for candidates to check their university career data in their student record book and if it is not up-to-date as of 10 August 2021 they must notify to their respective addresses studenti.triennale@iuav.it, studenti.magistrale@iuav.it.

Only for students in the first year of the three-year degree course who submit their application via Spin, if the candidate verifies that there are no examinations already taken in their university record booklet, they may declare them in the "Notes" field of the application. The merit calculation will take into consideration only those students who are up to date with the payment of the first instalment of university fees for the academic year 2021-22.

2 Each candidate will then be awarded a final score of up to a maximum of 100 points determined as follows (a) up to a maximum of 70 points for academic merit distributed as follows:

In the event of a tie, priority will be given to the candidate with the youngest age.

Handicapped candidates, with a disability of at least 66%, will be given priority in the ranking with reference to the seat of destination only. The certification of disability will be ascertained by luav

Activities to be carried out at the university abroad according to the Learning Agreement

After winning the exchange places, students receive an email and they are requested to reply and accept or refuse them by 28th March 2022


If the student who has been assigned renounces the place won, the office may proceed to assign the place made available to another winner according to the order of the ranking. Failure on the part of the candidate to express his/her acceptance/withdrawal by computer, the student will be automatically moved to the last place in the ranking.

After receiving the replies by 28th March, luav nominate the students to the foreign universities

Students must indicate which learning/educational activities they wish to carry out abroad when submitting their application. This information is merely indicative and does not prevent students from choosing other activities for their official study plan (the Learning Agreement) when they arrive at the foreign Universities. Learning agreement and changes of learning agreement must always be approved by luav tutor and host Universities before the beginning of the activities.

the activities permitted during the mobility period for study are:

- 1. learning activities (taught) and related assessment tests (exams);
- 2. collection material and preparation for thesis which must be discussed at luav.



Depending on the evolution of the epidemiological situation in the world, virtual learning activities may be authorised, and if positively evaluated, they will be recognised in the career.

Entry Visas and Study Permits

Successful students travelling to non-EU countries such as the United Kingdom, Albania, Bosnia-Herzegovina and Israel are required to consult and contact the diplomatic representations of these countries here in Italy in order to carry out the necessary paperwork for entry visas, health care and other additional procedures to be able to stay in these countries. The costs and management of these procedures are entirely the student's responsibility and vary according to the period of stay.

Students who are non-EU citizens, in addition to being regularly enrolled at the IUAV University of Venice, must have a residence permit, if present on Italian territory. It should also be borne in mind that, in the event of acceptance by the foreign university, the possibility of undertaking the exchange is always subject to the issue of an entry visa in the country of destination (a practice that must be followed personally and well in advance of the date of departure). Please note that in order to obtain a visa, some countries require students to certify that they have financial means available. The minimum amount is variable and sometimes higher than the amount of the sum of the mobility grants.

It is possible that during mobility at Host University, permit for study at luav expires and students are called back to the Police Headquarters in Marghera to renew permit for study at luav. Students will have to carry out this administrative procedure autonomously, that is it could happen that while students are in mobility, they will have to come back to Venice at their own expense for some days to renew study permit at the Police Headquarters in Marghera and they will have to prove that they have an accommodation in Venice for their course of studies at luav even if they are temporarily abroad.

Funding

While outgoing students are at the host Universities, they continue to be IUAV students so they must continue to pay any fees to IUAV to maintain the enrolment in academic year in 2022/23.

Outgoing students do not have to pay tuition fees to host Universities

If luav students usually receive grant from the luav Right to Study Office or reduction of luav fees, please keep in touch with the luav Right to Study Office to maintain these benefits. they do not have to ask the luav International Mobility Service for these benefits

All funding is allocated solely in order to carry out eligible activities to be carried out at the host institute, with a duration of no less than 2 months (60 days) and no more than 12 months during academic year 2022/23

Funding for students on mobility does not take the form of scholarships intended to cover all expenses, but rather represents a grant towards the additional expenses associated with living abroad.

Erasmus students going to foreign universities in countries such as Finland, Iceland, Sweden, Norway, Ireland, the United Kingdom, Denmark and Switzerland will receive a monthly grant of € 350.00.

Erasmus students going to foreign universities in countries such as Austria, Belgium, Cyprus, France, Germany, Greece, the Netherlands, Spain and Portugal will receive a monthly grant of € 300.00.

Erasmus students going to foreign universities in countries such as Slovenia, Bulgaria, Croatia, Estonia, Lithuania, Poland, Romania, Serbia, Czech Republic, Turkey will receive a monthly grant of € 250.00

An additional monthly grant of € 250.00 may be envisaged for Erasmus students with disadvantages and fewer opportunities, which will be assessed before departure following an application and subsequent presentation of self-certification.

Erasmus students with fewer opportunities are those who, for economic, social, cultural, geographic or health reasons, linked to their migratory background, or for reasons such as disabilities and learning difficulties or any other reason, including those that may give rise to discrimination within the meaning of Article 21 of the Charter of Fundamental Rights of the European Union, face obstacles that prevent them from enjoying effective access to the opportunities offered by the Erasmus programme.

By way of example, participants with fewer opportunities are defined as

- participants with certified physical, mental and health problems
- economic disadvantage as defined by ISEE see below
- cultural differences e.g. individuals from a migrant background and refugees, national or ethnic minorities, people with difficulties in linguistic adaptation and cultural inclusion, etc.
- students with minor children
- working students
- students who are professional athletes
- students orphaned by at least one parent
- students who are children of victims of terrorism and organised crime.

Furthermore, female students enrolled in STEM (Science, Technology, Engineering e Mathematics) courses, i.e. degree courses in the architecture group, may be also considered a preferential but not exclusive criterion.

There can be additional European funding made available to disabled Erasmus students and is allocated annually after participation in a specific and subsequent call for applications published by the National Agency. Disabled Erasmus students will be informed about the call and its terms by the International Student Mobility Service.

There can be additional European funding made available to Erasmus students who will use sustainable means of transport to travel to the host university (e.g. train, bus, car sharing, etc.), more information will be provided to the winners.



There may be a further economic integration depending on the funding made available by the university and/or other institutions such as by Miur Italian University Ministry This integration will be granted to students in mobility who are eligible and/or successful in the 2022/23 academic year in the IUAV (Diritto allo Studio - Right to Study) lists and who will be verified by the International Mobility Service. Students interested in this integration must apply by 31 July 2022 for the benefits of the Right to Study according to the deadlines and procedures provided by the luav Right to Study Service.

Mobility grants to Swiss Universities will be provided by the accepting Swiss universities themselves; winners of such exchange places must apply individually to the accepting Swiss Universities to receive the grant

Only ICM students going to Polytechnic University of Tirana will be given a grant of € 700,00 per month + € 275,00 for round-trip travel expenses (upon presentation to luav of the airline ticket and round-trip boarding pass); the mobility must end by 31 July 2023

Only ICM students going to the University of Banja Luka will be given a grant of € 700,00 per month + € 180,00 for round-trip travel expenses (upon presentation to luav of the airline ticket and round-trip boarding pass); the mobility must end by 31 July 2023

Only ICM students going to Bezalel Academy of Arts and Design or Holon Institute of Technology will be given a grant of € 700,00 per month + € 360,00 for round-trip travel expenses (upon presentation to luav of the airline ticket and round-trip boarding pass); the mobility period must end by 31 July 2023.

Eventual authorised extensions of the mobility periods might be also financed. The request of authorization for an extension must be sent to International Student Mobility Service at least a month before the end of the first exchange period

The grant for students on Non Erasmus+ mobility in non-European universities based in the northern hemisphere is € 700 per month. This grant derives from Iuav and/or from Miur Italian Universy Ministry

Students can receive the grant from IUav only if there is physical mobility. When outgoing students have arrived at Host Universities, there they must register themselves as exchange students. Host Universities provide them with a certificate of arrival that they will send by email to Iuav International Mobility Service so that they can receive an advance of the grant equal to 80% on their bank account that they have registered on Spin

When outgoing students have finished mobility abroad, the Host Universities provide them with the final certificate of attendance and the transcript of record with the exams you passed

Outgoing students have to send these documents to luav International Mobility Service and students will have the balance of the grant according to your actual presenceabroad. Even the balance will be transferred on your bank account

Students who fail to complete any study activities with passing grades shall return the full amount of the funding received. Any exception to this rule could be approved only for reasons of force majeure

Deadlines

- -applications must be done until Tuesday 8th March 2022 h 12.00 noon, the submission of applications is via SpIn;
- during the period of the calls students must fix an appointment by email to info@istitutozambler.com for the language test, test to be taken by Thursday 10 March 2022;
- infoday 2 March 2022
- from Friday 25th March 2022 publication with the results of selection on luav website;
- by Monday 28 th March 2022 acceptance/withdrawal of the place won by replying luav email request to your personal email address
- with the publication of the definitive rankings, indication of the dates of allocation of vacancies.

The above deadlines may be subject to changes, which will be promptly communicated on the IUAV website.
